## **ORDINANCE NO. 330-2017**

AN ORDINANCE OF THE BOROUGH OF NORTH APOLLO, COUNTY OF ARMSTRONG, COM-MONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE FOR THE YEAR 2018

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Borough Council of the Borough of North Apollo, County of Armstrong, Commonwealth of Pennsylvania:

SECTION 1 That a tax be, and the same is hereby levied on all real property within the Borough subject to taxation for the fiscal year 2018 as follows:

Tax rate for general; purposes, the sum of eleven and fifty- nine hundredths mills on each dollar of assessed valuation, or the sum of one hundred-fifteen and nine-tenths cents on each hundred dollars of assessed valuation; making a total for all purposes of eleven and fifty- nine hundredths mills on each dollar of assessed valuation, or the sum of one hundred-fifteen and nine-tenths cents on every hundred dollars of assessed valuation.

SECTION 2 That any ordinance, or part of ordinance, conflicting with this ordinance be and the same is hereby repealed insofar as the same affects this ordinance.
