ORDINANCE NO. 347 of 2022

AN ORDINANCE OF THE BOROUGH OF NORTH APOLLO, COUNTY OF ARMSTRONG, COMMONWEALTH OF PENNSYLVANIA, TO ABOLISH THE OFFICE OF ELECTED AUDITOR AND ESTABLISH THE OFFICE OF APPOINTED AUDITOR PURSUANT TO §1005(7) OF THE BOROUGH CODE

WHEREAS, the North Apollo Borough Council finds that it is in the best interests of the Borough to abolish the office of Elected Auditor and appoint an independent auditor pursuant to the provisions of the Pennsylvania Borough Code;

NOW, THEREFORE, the Borough of North Apollo enacts the following ordinance:

Section 1. The office of Elected Auditor for the Borough of North Apollo is hereby abolished.

Section 2. Borough Council shall appoint an independent auditor who shall be a certified public accountant registered in this Commonwealth, a firm of certified public accountants registered in this Commonwealth or a competent public accountant or a competent firm of public accountants. The independent auditor shall be appointed annually, by resolution before the close of the fiscal year, to make an independent examination of the accounting records of the borough for the fiscal year, and the independent auditor shall also perform the other duties and exercise the powers as conferred upon the independent auditor under Subchapter C (relating to auditors) of the Borough Code.

Section 3. The Borough shall have the right at any time to repeal this ordinance and abolish the office of appointed auditor.

Section 4. All ordinances or resolutions or parts thereof that are inconsistent with the provisions of this ordinance are hereby repealed.
